

TERMS & CONDITIONS:

NOTE: Reservation benefit shall be applicable to Bihar State Domicile Candidate only and the applicant from outside the state of Bihar will not be entitled to the reservation. The physically handicapped candidate will be given the benefit of reservation and relaxation as per the rules of the Government of Bihar. Also, in case of unavailability of eligible FEMALE candidates (Where applicable), MALE candidates for the respective department may be considered.

Pay Scale: As per the Institution's Rule.

Upper Age Limits: 45 (Forty Five) years as on the date of Interview (Relaxation as per State Govt. Rule: 05 years for SC/ST, 03 years for EBC / BC, and 03 years for all categories of Female Candidate).

Essential Qualifications & Experience for Senior Resident:

MD/MS in Anatomy.

The scheme of marking for ad-hoc appointments shall be as follows:

- (ii) MS/MD/DNB 10 marks (-5 for each failure)
- (iii) Additional qualification 10 marks (iv) Publication – 10 marks (6+4)

- (v) Poster/Presentation 10 marks (2 marks each for a maximum of 10) (vi) Academic Award – 10 marks (2 marks each for a maximum of 10)
- (vi) Academic Award 10 marks (2 marks each for a maximum of 10)
 (vii) Specialised training 10 marks
- (vii) Specialised training 10 marks
 (3 months training: 2 marks/3-6 months training: 5 marks/> 6 months training: 10 marks)
- (viii) Project (extra/intramural) 10 marks (ix) Subject Knowledge – 20 marks

Total = 100 marks

The minimum qualifying criteria for appointment to the post of Senior Residents shall be as follows:

- (i) UR 50th Percentile
- (ii) BC/EBC/EWS 45th Percentile
- (iii) SC/ST 40th Percentile

The qualification prescribed in a minimum requirement, and the same does automatically make the Candidate eligible for an interview. Based on bio-data, the Selection Committee of the Institute will select candidates for appointment. Candidates who are interested in the interview will have to produce all original relevant certificates/documents, in proof of the details furnished in their application at the time of the interview.

An Indian citizen, who fulfills the essential qualifications etc., is invited to participate in this Walk-in-Interview as mentioned above, along with their thesis, and publication - To be presented in Power Point (Please bring your PPT in pen-drive) and application form in the prescribed proforma with copies of all supportive certificate/documents and bring all original certificate/documents, in proof of Age, Qualification/s, Registration etc.

GENERAL INSTRUCTIONS

- 1. The application form can be downloaded from our website, www.igims.org. The fee for the application:-Rs. 1000/- (Rupees One Thousand) for UR/EWS/BC candidates and Rs. 250/- (Rupees Two Hundred & Fifty) for EBC/SC/ST candidates (Non-Refundable) payable to "Director, IGIMS Patna" in the form of a Demand Draft.
- 2. Candidates employed in a Government/Semi-Government Department or any other employer must submit their application along with a "No Objection Certificate" issued by the employer at the time of the interview; otherwise, they will not be considered for selection. In case of not being employed, candidates must submit in writing that they were neither employed at any organization nor doing any course anywhere.
- 3. SC/ST candidate must attach their Caste Certificate issued by the Circle Officer of the respective District/Circle of Bihar along with application form EBC(MBC)/BC candidate must attach their Caste Certificate along with Certificate of exemption from Creamy Layer duly issued by the Circle Officer of respective District/Circle of Bihar along with application form, if claimed for reservation.
- 4. Reservation points and relaxation in the upper age limit will be applicable as per the rules of the Government of Bihar. The benefit of reservation will be given to Bihar State domiciles only, and the applicants outside the state of Bihar will not be entitled to the benefit of reservation. A handicapped person/candidate will be given the benefit of reservation as per the Government of Bihar. The person working in the government. The institution shall be given relaxation as per the rule.
- 5. The number of vacancies in the department may increase or decrease. Also, in case of unavailability of eligible FEMALE candidates (where applicable), MALE candidates for respective departments may be considered.
- 6. In addition to Pay + NPA, other allowances will be admissible as per the rule.
- 7. The post is non-practising, Private Practice of any kind, direct or indirect, including laboratory, is strictly prohibited, and if found indulging in such private practice, the appointment of the candidate shall be terminated.
- 8. Selected candidate/s have to submit a LEGAL BOND that they will deposit an amount equivalent to the amount paid to them at the rate of one month's emoluments for every year of the Sr. Residency Programme not completed, on quitting/resigning from the Sr. Residency Programme, mid-way.
- 9. Staying on campus is compulsory; if accommodation is provided, if not provided, HRA's admissible as per rule.
- 10. The Director of the Institute reserves the right to reject/accept any or all the applications without assigning any reason, and cancel the advertisement.
- 11. Canvassing in any form will be a disqualification.
- 12. No TA/DA is admissible for attending the interview.
- 13. A declaration that whether they have filled up- the Declaration form and appeared before the M.C.I Team for the year 2025-26, for any Medical College or not, should be submitted with the application.
- 14. Merit selection by the Selection Committee does not give the right of appointment to the candidate. The Institute reserves the right of appointment of the candidates recommended by the Selection Committee.
